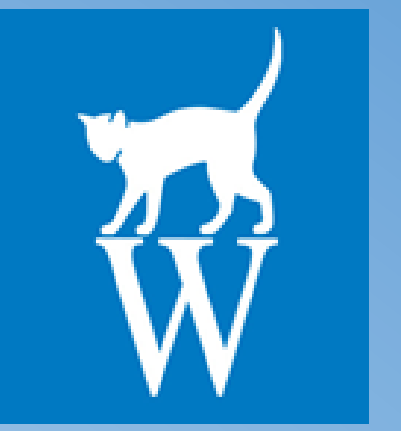




Integrating Schwartz Rounds into the Foundation Year Curriculum

Background

In 2017 we successfully relaunched Schwartz Rounds at the Whittington Hospital. Previous work has indicated benefits of Schwartz Rounds for individual members of staff, organisations and patient experience.

Foundation year doctors in our cohort were generally keen to attend, however the fact that Schwartz Rounds were not included in protected teaching time meant that it was often too difficult to attend.

The current method of assessing professionalism for foundation year doctors can become a tick box exercise, and provides little opportunity for multi-disciplinary or group work.

One solution to this would be to incorporate Schwartz Rounds into the national Foundation Programme curriculum.

Results

The nature of the problem (that foundation year doctors find it difficult to attend Schwartz Rounds) of course led to challenges in collecting data.

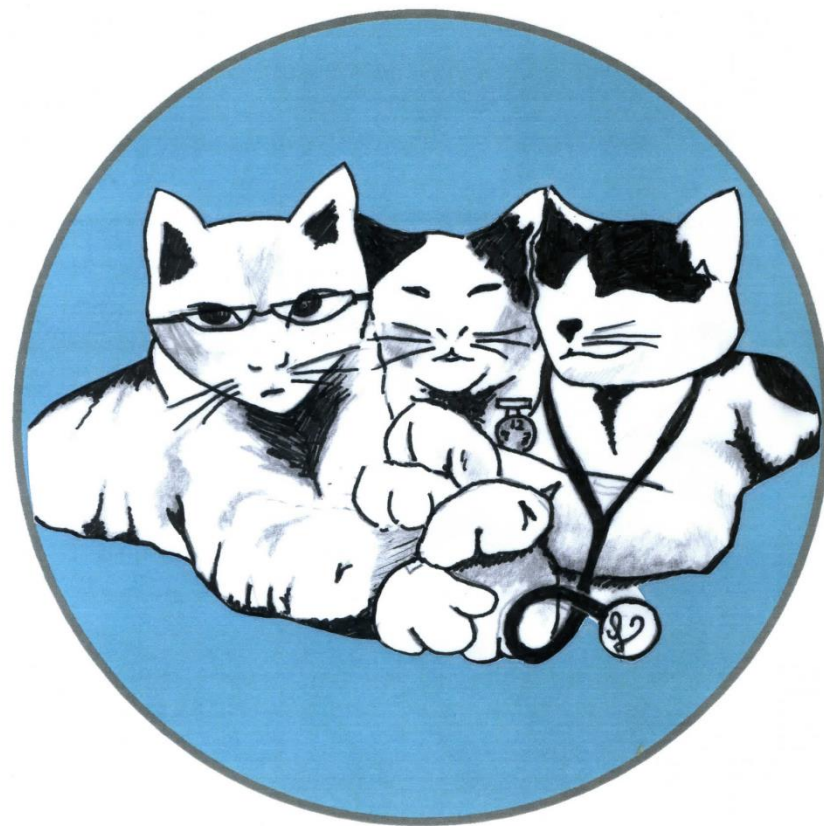
Our Schwartz Rounds

“When things go wrong, how many victims?”

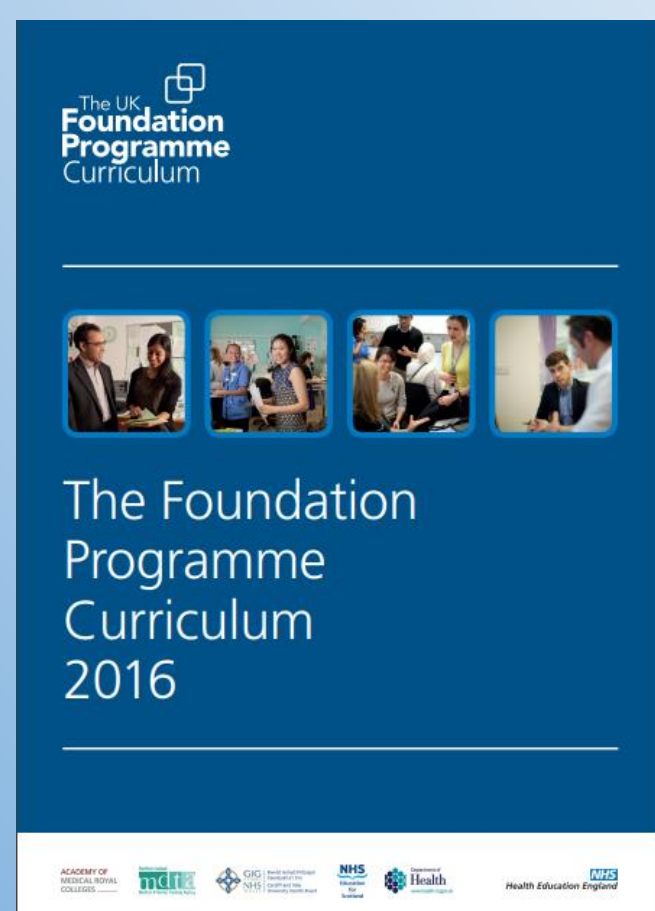
“Out of my comfort zone”

“The patient I will never forget”

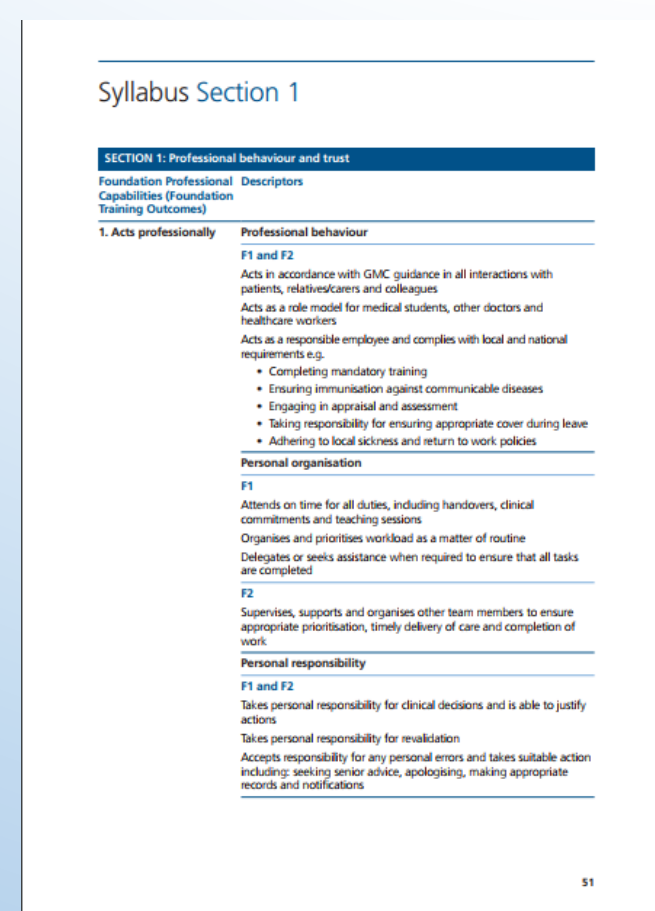


Foundation Programme Curriculum

The UK Foundation Programme is based on 20 core Professional Capabilities, of which seven are covered by Schwartz Rounds:



Professionalism
 Patient centred care
 Ethical and legal requirements
 Communication
 Team working
 Personal competence
 Patient safety



Conclusion

Previous research has shown the benefits of doctors attending Schwartz Rounds, and the limited data collected here supports this. Skills associated with Schwartz Rounds correlate well with several Professional Capabilities, making up the Foundation Programme Curriculum. Incorporating Schwartz Rounds into the national curriculum would enable more foundation year doctors to attend, and could play a role in the assessment of professionalism of doctors in training.
